#### 54. Prayers

The Chairman welcomed everyone to the meeting, which she opened with prayers for the work of the Council.

#### 55. Apologies

Councillor K.D.Roughley had informed that he was attending a meeting of the Planning Committee and would thus be arriving as soon as possible thereafter.

#### 57. Declarations of Interest

As Councillor Roughley was a member of St.Helens Council Planning Committee, he would thus leave the room when planning matters were discussed.

No other declarations were made.

#### 58. Parish Matters

The Police Officers present and the Parish Council exchanged reports and views on current and persistent problems including; dangerous parking by parents etc., when delivering or picking up children to and from both Bleak Hill and Windleshaw schools.

Other subjects discussed were the traffic problems at the Kiln Lane/ Coronation Road Junction, youth misbehaviour, and Lynton Way Play Area.

The Council were dismayed at the news of yet another local police reorganisation, which would result in Windle only being served by one police constable assisted by one C.S.O. Other parts of the town would similarly be effected.

The Chairman Cllr. Mrs. K.S. Barton thanked the officers for their valuable input into the discussion and exchange of information. At this point the officers left the meeting.

59. Minutes

The Council received the minutes of the Parish Council Meeting, held on the 20<sup>th</sup> June 2006, which had been circulated previously.

Resolved that, prior to confirmation as a true and correct record, the following amendment be made to min. 52 (b) ;
