47. Prayers

The Chairman welcomed every one and opened the meeting with prayers for the work of the Council.

48. Apologies

*Apologies were expressed on behalf of Cllr. W .Ashcroft- attending a prior meeting – but hoping to arrive later, which he did at 7.15pm.

49. Declarations of Interest

No declarations were made.

50. Parish Matters

- a) A Windle resident had received a parking fine of £30 from Perth in Scotland but had protested that he had never been to Perth. The matter had now been referred to St Helens Council Trading Standards Dept.
- b) People need to be made aware that there were criminal activities whereby older residents were being approached by a man proposing to check their electrical sockets, and thus gaining entrance to their homes and enabling property to be stolen.

There was also a report of a company from Fleetwood using telesales contacts to send consultants to discuss reseals on double-glazing and sign people up for £3000 guaranteed reseals- again older residents, in our area, may be targeted and prove vulnerable to these approaches.

Also reported were instances of incidents on the Asda car-park, involving men employing a scam operation ,under the pretext of sampling a new perfume which had resulted in young women being drugged and robbed.

c) The land on Bleak Hill Road- formerly the site of Frenchs Farm – and now belonging to Henderson Homes, the builders, which has been allowed to become

severely overgrown in recent years has been subjected to some clearance by heavy – plant machinery belonging to Hendersons.

- d) St Helens Council were consulting with the three Windle Ward Councillors to determine some suitable means (e.g. tree planting or flower boxes etc.) to deter carparking on the pavements at the junction of Coronation Rd, Regal Dr. and St.George's Ave. and to enhance the area. The residents in the immediate vicinity would be consulted by the Ward Councillors before they made their choice.
- e) It had been determined that the Alder Hey Road Allotments were in the Windle Ward

51. Minutes

The reply received from Mr.J.Widdop(Public Right of Way Office- St Helens Council) had suggested that letters requesting this be made so, be sent to the landowner and his agent.

Resolved that such a letter be sent by the Clerk, and any interested residents be urged to do the same.
